REGIONAL CONSULTATIVE AND ENGAGEMENT MEETINGS ON THE DEVELOPMENT OF THE SECOND NATIONAL ANTI-CORRUPTION STRATEGY AND ACTION PLAN 2021-2025

One of the Namibian Government's priorities towards economic recovery and inclusive growth is the implementation of anti-corruption policies in all institutions to ensure effective governance. In conformity with this principle, Namibia signed regional and international legal instruments on fighting corruption and money laundering such as the SADC Protocol against Corruption, AU Convention on Preventing and Combating Corruption, United Nations Convention against Corruption and the United Nations Transnational Organised Crime.

In August 2016, Cabinet approved the country's first National Anti-Corruption Strategy and Action Plan 2016-2019, which ended in March 2020. Subsequently, at its meeting on 9th March 2021 by Decision No.3rd/01.03.21/012, Cabinet took note and appreciated the progress made in implementing the anti-corruption activities, and therefore decided that consultative and engagement meetings for the development of a second revised National Anti-Corruption Strategy and Action Plan be held, which must culminate in the implementation of the anti-corruption programmes for the period (2021-2025).

The Anti-Corruption Commission, as the coordinating institution of the National Anti-Corruption Strategy, will be holding consultative and engagement meetings in all the 14 regions with an objective to bring stakeholders under one roof to make inputs that would shape the second National Anti-Corruption Strategy and Action Plan 2021-2025. Further, the Strategy is being developed in line with Article five of the United Nations Convention against Corruption (UNCAC), which calls for State Parties to develop and implement effective governance, coordinate anti-corruption policies that promote the participation of society and reflect the principles of the rule of law, proper management of public affairs and public property, integrity, transparency and accountability.

Against that backdrop, the Commission is therefore inviting members of the public, interested and affected strategic stakeholders to partake in the process and give their views, inputs and make their immense contributions during the consultation and engagement meetings of the drafting of the second National Anti-Corruption Strategy and Action Plan (2021-2025).
