**SUBJECT: INVITATION TO THE LAUNCH OF THE SIXTH NATIONAL
DEVELOPMENT PLAN (NDP6) PROCESS**

The National Planning Commission (NPC) is embarking upon the process of formulating the Sixth National Development Plan (NDP 6). As you are aware that the NDP5 came to end in March 2022, initially, the National Planning Commission was granted the authority by Cabinet to extend the implementation of the NDP5 to over 2022/2023. Subsequently, Cabinet, upon Cabinet Committee on Trade and Economic Development (CCTED) and Cabinet Committee on Trade (CCT) recommendations, approved to prioritize the implementation of Harambee Prosperity Plan (HPP II) and Extended NDP5 for the periods 2022/2023 - 2024/2025. Hence HPP II will serve as the Development Framework for 2022/23 – 2024/25.

It is in this context that the National Planning Commission conducted a co-joint media briefing with Ministry of Information and Technology as per the Cabinet Decision No: 18th/18.10.22/004 on 27 March 2023 to inform the nation on the country's current development framework and, that NPC will start with the formulation process of the Sixth National Development Plan with wider stakeholders' consultations during 2023/2024 Financial Year. The whole process of developing the NDP6 will be done in two financial years, 2023/2024 – 2024/2025 to allow citizens to fully participate in this vital exercise. Hence, the formulation of NDP6 is planned to commence with a launch of the processes.


