Dear civil society organizations and land activist,

We are pleased to invite you to a "Workshop to Review progress on implementation of Resolutions of the 2<sup>nd</sup> National Land Conference (October 2018) on Urban Land Reform with special reference to Upgrading of Informal Settlements!

Civil society organizations during their presentations at the 2ndNLC challenged President Dr Hage Geingob to make **the improvement of living conditions in informal settlements a legacy of his Presidency**. In addition, civil society organizations pledged to work with government and in particular the Presidency, line Ministries, the private sector, professional bodies and development agencies to improve the situation in informal settlements.

While closing the 2nd National Land Conference (2ndNLC), **President Hage Geingob declared that the situation in informal settlements to be an "national emergency" and a "humanitarian crisis".** This was a key recognition that the living conditions in informal settlements requires urgent and concrete action.

# Almost three years after the 2<sup>nd</sup> National Land Conference, this workshop will review progress with implementation of the resolutions and formulate proposals from civil society organizations in terms of the way forward!

### **Objective of the workshop:**

- Critically assess the latest progress report from the Ministry of Urban and Rural Development to the High-Level Committee (Chaired by Prime Minister) for the implementation of resolutions of the 2<sup>nd</sup> NLC.
- Review current and ongoing interventions and initiatives (especially after the 2ndNLC) by various stakeholders with regards to upgrading of informal settlements and urban land reform in general.
- Development proposals from a civil society perspective and an advocacy plan to ensure resolutions of 2ndNLC on urban land reform are successfully implemented with a sense of urgency.
- Formulate submission to the next High Level Committee meeting scheduled for 6<sup>th</sup> September 2021.
